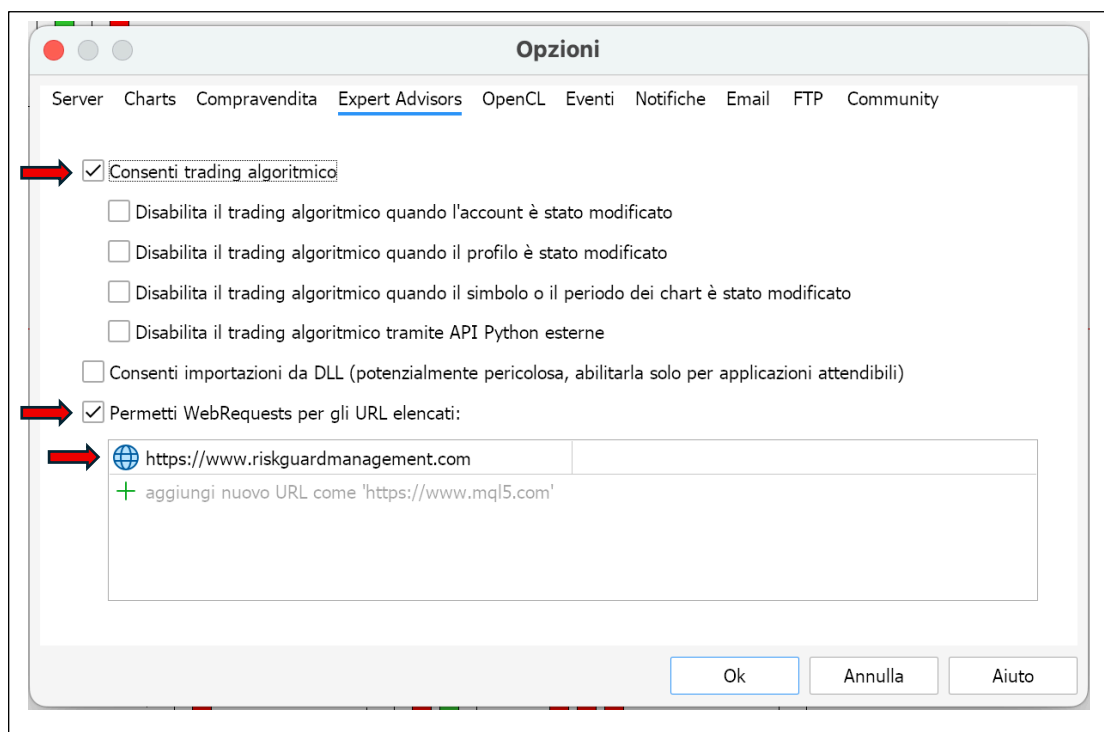


INSTALLATION INSTRUCTIONS

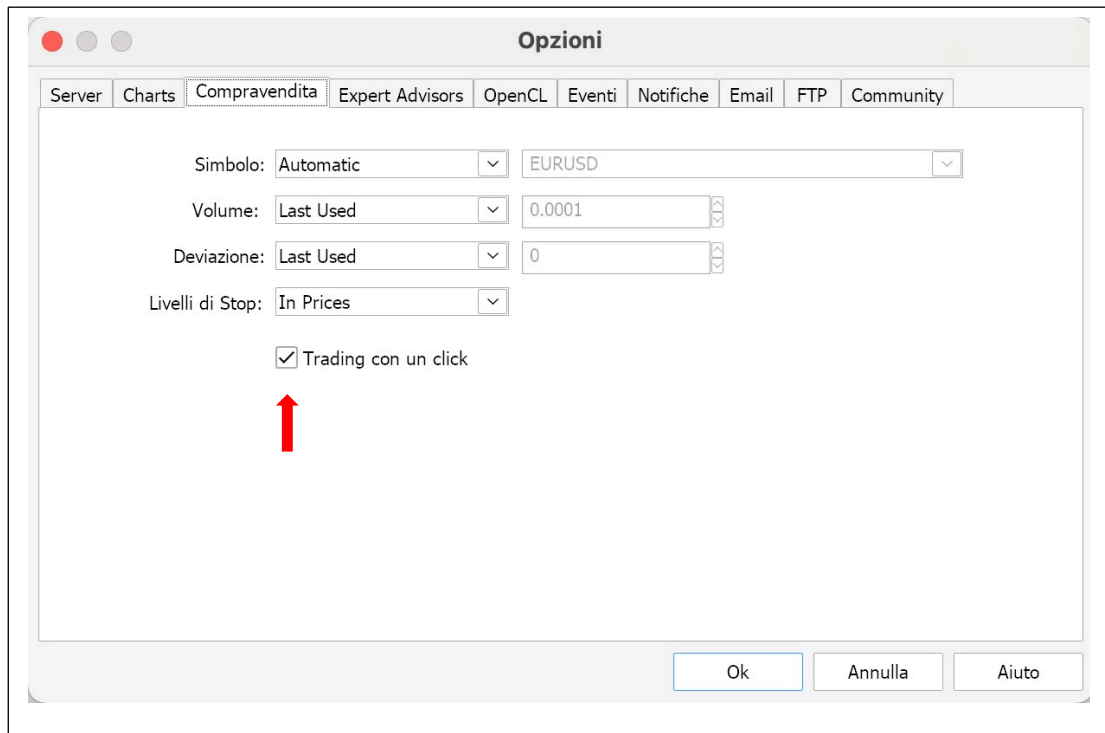

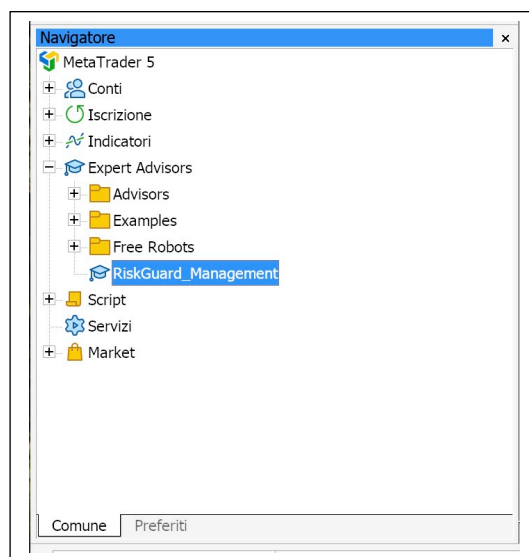
- WINDOWS USERS.** Take the file located inside the "2.0 Software" folder and open MetaTrader. Click on the **File** menu, select **Open Data Folder**, then select the **MT4** or **MT5** folder. Open the **Experts** folder and paste the file inside it.
- macOS USERS.** Take the file located inside the "2.0 Software" folder, open the Finder, and in the menu at the top left of your screen, click **Go**. Now press and hold the Option key on your keyboard. A new menu option labeled **Library** will appear. Click on it, then release the Option key. Select the **Application Support** folder, and look for the folder corresponding to your MetaTrader installation. In my case, it is called **net.metaquotes.wine.metatrader5**, but it may not have the exact same name for all Mac users. Look for the folder that matches your MetaTrader installation and open it.
Next, select the **drive_c** folder.
For MT4 users, open the **Program Files (x86)** folder.
For MT5 users, open the **Program Files** folder.
Now, open the **MetaTrader 4** or **MetaTrader 5** folder, then navigate to the **MT4** or **MT5** folder, and finally open the **Experts** folder. Paste the file inside this folder.
- Now, let's correctly configure the settings of your MetaTrader to use all the features of RiskGuard. Select **Tools**, then choose **Options**, and in the **Expert Advisors** tab, set the flags exactly as shown in the picture and add the new URL <https://www.riskguardmanagement.com>



3. Enable the **One-Click Trading** flag. This must be activated for each trading account within MetaTrader.



4. Now, in your **Navigatore**, double-click on the Expert. If you still don't see the Expert, follow the steps explained in the video: right-click on **Expert Advisor** and select **Refresh**.



- Now, by double-clicking on your Expert, the settings screen will appear. In the first field labeled **License**, enter your purchase order number followed by _ and the email address you used to purchase RiskGuard. This will activate your license.

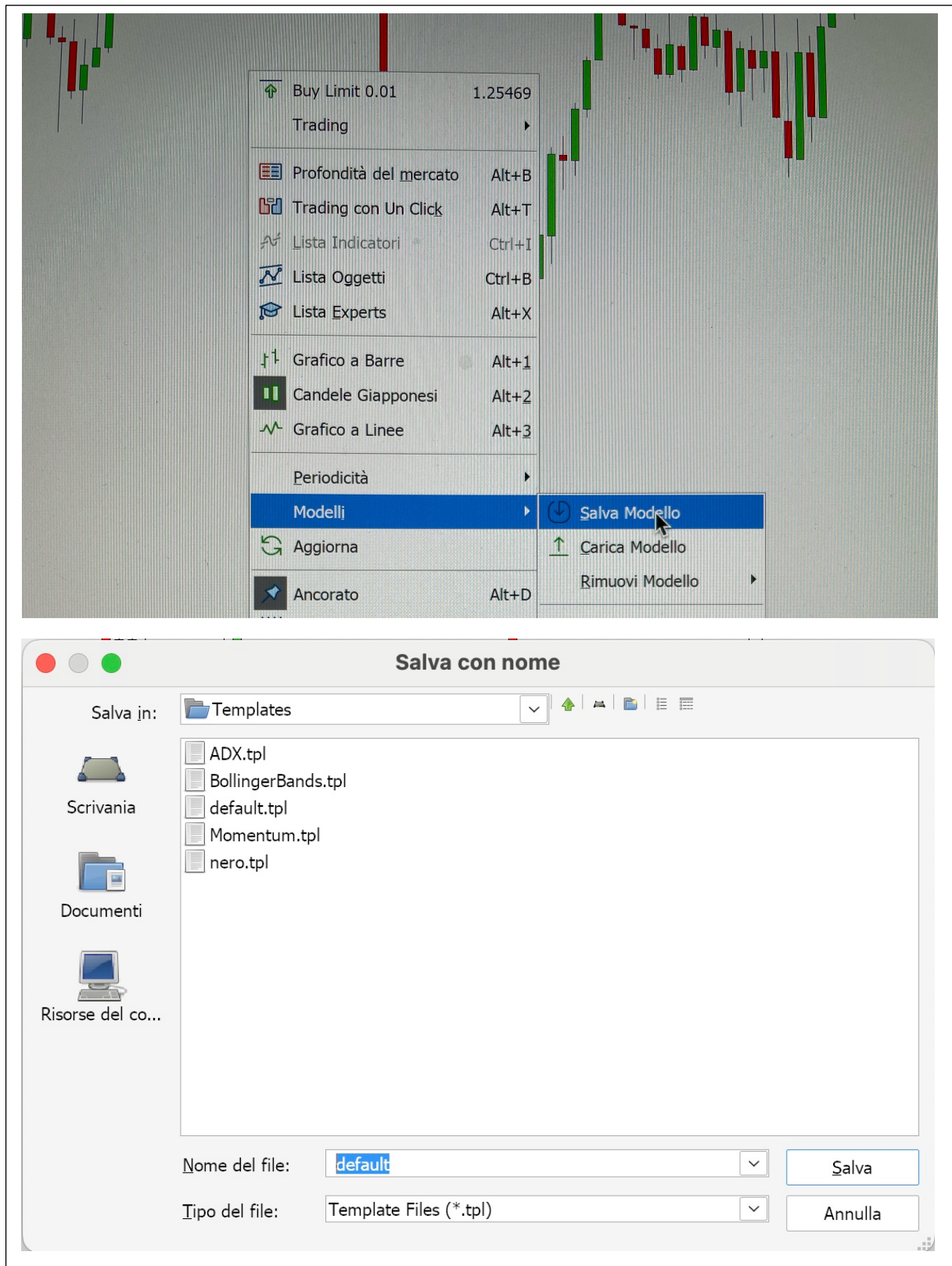

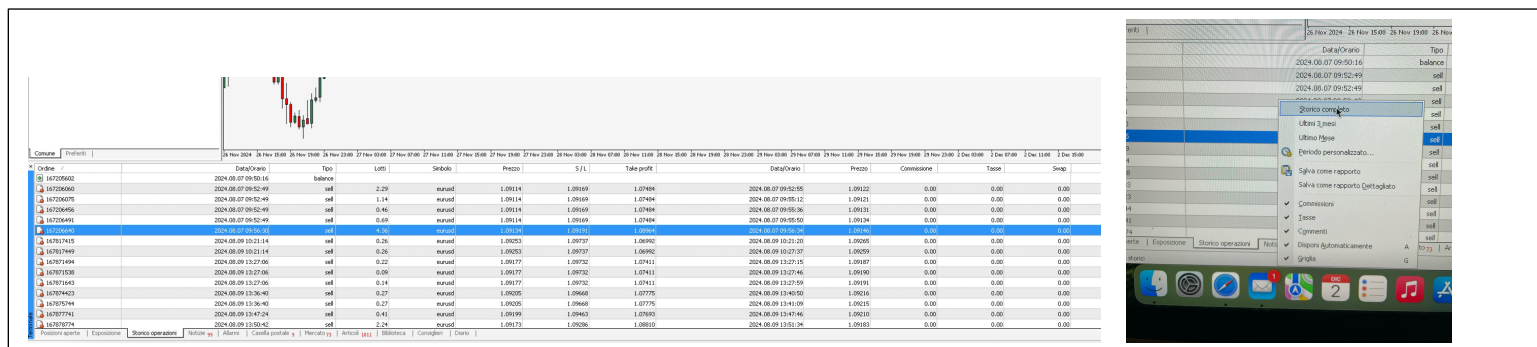
6. Once you have properly set up your RiskGuard and clicked **OK**, one of the most important steps is to save the template. Right-click on the chart, then go to **Templates**, select **Save Template**, and save it with the name **default**. This step is crucial and should be repeated whenever you change any parameters in RiskGuard's settings. This way, every time you open a new instrument, RiskGuard will already be applied to the chart with the saved settings.

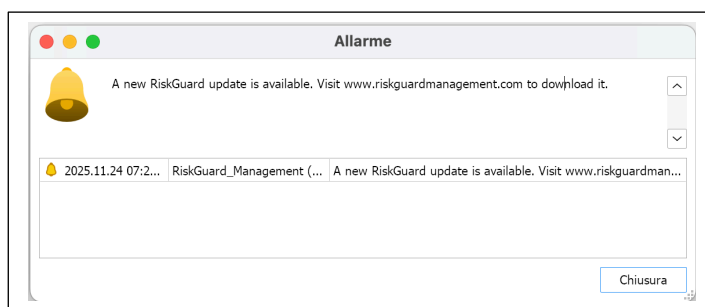

How to update RiskGuard Management

When a new version of RiskGuard Management is released, an on-screen notification will automatically appear



1. Make sure to close all chart windows where RiskGuard is active. This prevents leaving the old version running on any instrument.
2. Go to the **Download** section on our official website and download the latest version of the Expert Advisor.
3. Replace the old file with the newly downloaded one in your MetaTrader **Experts** folder.
4. After replacing the file, reload the default template on your charts to activate the new version properly.
5. You can verify the active version directly in the Expert Advisor settings (look for the *Version* field).

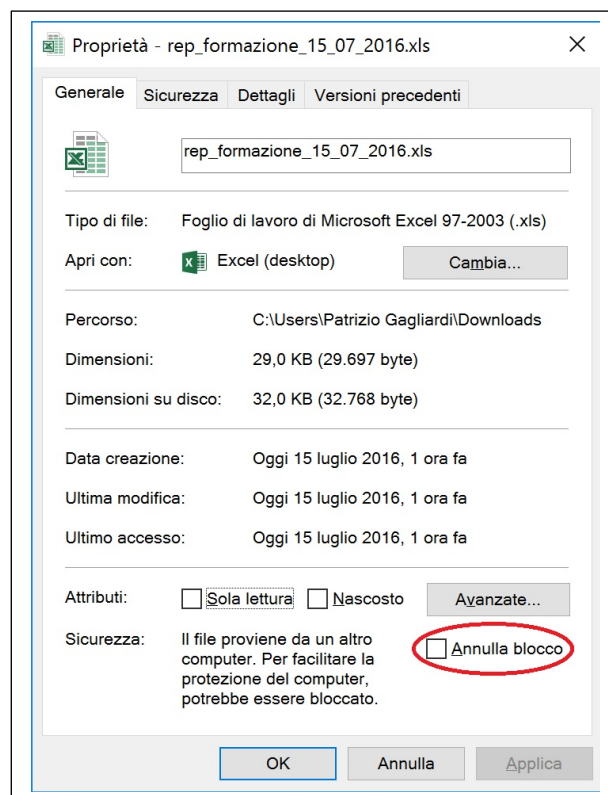
For macOS users, it is highly recommended to use the bug-free Excel version 16.90, available for download here:

For MacOS users, it is highly recommended to use Excel version 16.90, which is free of bugs. You will find the download link in the “installing the journal” section of the instructions.

3. Windows users, after downloading the journal, must right-click on the file, select **Properties**, and check the box for **Unblock** as shown in the image. This step is not required for macOS users. However, for both Windows and macOS users, macros must be enabled.





4. Once the journal is open, go to **Setting → Backtest**. Next to **Path Trade 1**, paste the path to the **File** folder — the same procedure described in step 1 for installing RiskGuard. Then, next to **Path Screenshot (OneDrive)**, **MacOS users only** must enter the path to the folder containing the screenshots. For each trade, RiskGuard automatically takes a screenshot and creates a folder under **File** named **Screen_RiskGuard**. This folder must be copied and pasted into OneDrive, and that path must then be specified in


the journal.


Windows users can simply leave “**ALL PATHS (only Windows)**” selected.
